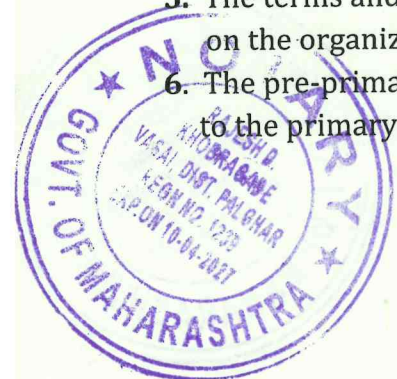

In the context of the above reference the approval of the grant is given as per the Government Decision No. Swayam-2013/(85/13)Mashi 1 dated 15th June 2013 including conditions and submitted as per the provisions of the Maharashtra Private School Employees Regulation Act 1977 and the Maharashtra Private School Employees (Conditions of Service) Rules 1981 as well as the provisions of the Free and Compulsory Education of Children Act 2009. As per the report recommendation and terms and conditions for acceptance are as follows:

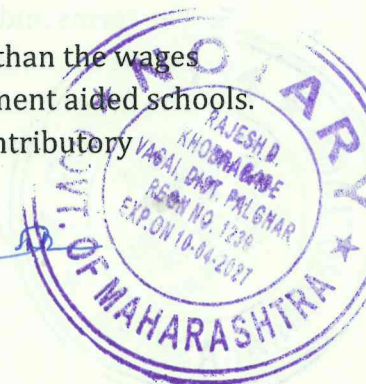
1. The provision of Right of Children to Free and Compulsory Education Act 2009 needs to be implemented.
2. Registered lease deed from registered secondary registrar in favour of the management of the school building and premises on ownership/rental basis.
3. A school has been started through the institution and an assurance has been given that no claim is pending in court regarding the proposal.
4. The institution/school shall comply with the Government's orders from time to time, the Secondary School Code and the Maharashtra Private School Staff Regulations 1977 and the Maharashtra Private School Staff (Conditions of Service) Regulations 1981 as well as the provisions of the Right of Children to Free and Compulsory Education Act 2009, Maharashtra Self-financing Schools (Establishment and Regulation) as per Act 2012 strict compliance of the provision is mandatory.
5. The terms and conditions of the Government Decision dated 27 May 2013 shall remain binding on the organization.
6. The pre-primary schools are not approved as separate schools but are approved as attached to the primary schools and the schools starting under them are being approved.

7. All the teachers and non-teaching staff working in the school of the institution should be recognized and the qualification of the teachers shall be as determined by the Government / Board from time to time.
8. According to the above order of the government, the principal should give admission to the classes which the institute is going to open according to the court order and government criteria. Donations of any kind should not be accepted at the time of entry.
9. Under the Maharashtra Educational Institutions (Prohibition of Capitation Fee) Act 1987 Maharashtra Act 6/88 dated 15/04/1988 the institution shall not collect any donation at the time of admission or thereafter or compel the student/parent/employee to do so.
10. The school shall follow the Secondary School Code and the Maharashtra Private School Staff Regulations 1977 and the Maharashtra Private School Staff (Conditions of Service) Regulations 1981.
11. The school will appoint teachers and non-teaching staff according to the approved posts. The said appointment should follow the quota prescribed for backward classes as per rules
12. As per the rules of the government, the Sanch Manyata site should be updated every year.
13. School accounts and all kinds of registers must be kept up to date.
14. A school should have a conducive environment for students, suitable building, well-equipped library/laboratory/separate teacher's room.
15. As per the provision of Government Decision No.PTA/2010/(347/10)/Mashi-2 dated 24/08/2010 it is necessary to establish a Parent-Teacher Association. Also, a school committee should be established and at least six meetings of the school committee should be held in a year and minutes should be kept.
16. The level of education, facilities for education, health facilities should be as per the standards and separate toilets for boys and girls are required in proportion to the number of students. Provision of drinking water, playground etc. must be provided.
17. The institution shall charge the tuition fees from the students as determined with the prior approval of the Govt. which will remain binding. It will be necessary to take appropriate action regarding safety, especially in terms of fire prevention, all arrangements for the health of the students and preventive vigilance to avoid any accident from fire.
18. No change can be made in medium and place of school etc. prescribed by the institution for school permission.
19. If a school is started at a place other than the place where permission has been given by the government, the permission given by the government will automatically be considered cancelled.
20. A school approved under the Maharashtra Self-financing Schools (Establishment and Regulation) Act, 2012 cannot be shifted to another place in future.
21. Schools permitted under the Self-Financing Schools (Establishment and Regulation) Act, 2012 are being registered as Self-Financing Schools.
22. The school building is adequate and educationally suitable and Government decision dated 03/11/2009 six months from the date of first approval of the certificate of compliance with the National Code 2005. It should be noted that it should be submitted within a month otherwise the first approval given will be automatically cancelled.
23. The wages and allowances to be fixed by the management shall not be less than the wages and allowances fixed by the Government from time to time for non-government aided schools. And these wages and allowances should be paid through the bank. Also, Contributory Provident Fund Scheme should be started.

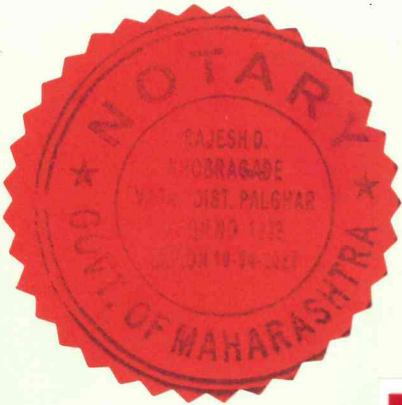

24. Your school will be given the first accreditation for grade 2nd to 8th English Medium (Primary and Middle School) based on the documents submitted by you. If the information submitted by you is found to be false or any court case arises in the future, you will be solely responsible for it and the first approval will be cancelled for Class 2nd to 8th English Medium (Primary and Middle school) with the promotion given.

Subject to the above terms and conditions, Notre Dame School, English Medium, Tarkhad, Taluka Vasai, District Palghar, run by The Vasai Notre Dame Sisters Society, Bangali Naka, Sandor, Taluka Vasai, is a Self-Funding School from the year 2010-11 as "Maharashtra Self-Funding School (Establishment and Regulations) Act, 2012" with promotion as a primary school to first recognition grade 2nd to 8th English Medium (Primary and Higher Primary) is being offered.
